of their judgment, the judge will be found in error as a matter of law, and the appellate court is authorized to reverse the finding of the trial court. *Stump v. First Nat. Bank of Paducah*, 339 S.W.2d 84 (Ky.1960). A trial judge is empowered to give a peremptory instruction when the instructions and evidence have established the fact with absolute certainty and he finds the other to be an improper or erroneous assumption. *Hancock v. Smith*, supra; 17A C.J.S. Contracts § 556, p. 946. The evidence of this case is in dispute and each of the parties offered proof sufficient to create a factual issue. The trial judge correctly ruled that the appellees had the burden of proof and that the appellant had no duty to prove its innocence. The appellant maintains that the uncontradicted evidence shows that it had not done anything to violate the contract terms. This contention is not in accord with the evidence, the reasonable inferences therefrom, or the findings of fact by the trial judge. The appellant did not deny that the *85 appellees had complied with the contract terms. The appellant admitted that if appellees had paid a total of \$75,000.00 it was entitled to a new well. The appellant's representative denied that appellees had paid the \$75,000.00 and denied that the contract required the appellant to provide appellant with a new well, if appellant paid the appellees the \$75,000.00. The appellant has failed to convince this court that the judgment of the trial court was clearly erroneous. The judgment is affirmed. All concur.
