Uploader: WPMU-CMHUB1 Size: 2228871A leftist group has hired lawyers in a bid to force the Council on American Islamic Relations (CAIR) to respond to a Freedom of Information Act (FOIA) request for documents relating to alleged terrorism financing by the Qatar Islamic Bank. The legal team for the Palestine Legal organization says CAIR must provide the Qatari bank the requested records by January 3, 2015, or a lawsuit will be filed. Qatar Islamic Bank is headquartered in the United Arab Emirates, which critics say is a strategic and financial ally of the Arab kingdom of Qatar. CAIR, a group that was forced to admit on Friday it was behind a Texas billboard campaign calling for Israel to be "wiped off the map," has expressed staunch opposition to the 9/11 attacks and the US policy toward the Arab world, and was also caught on film last year celebrating the death of alleged US Army whistleblower Bradley Manning. In 2014, the New York-based group became the subject of a fundraising boycott campaign after it called on Minnesota Congresswoman Ilhan Omar to resign from Congress because she was "openly hostile" toward Israel. Omar is the only member of Congress to back a boycott of Israel. So when Palestine Legal filed its FOIA request for bank records, this is not only what it asked for, this is everything that the bank is required to produce as part of the information they supplied and shared with the US government, it adds. The records Palestine Legal is after include contracts, investment proposals, legal opinions, and government banking data provided to the US government. In the past, some of this data was available on the bank's website, but not everything was. It asks for a response by January 3, 2015, and says that if no response is received, a "legal notice" will be sent to the bank and Palestine Legal will take necessary steps to compel the Qatar Islamic Bank to produce the information. "The bank has benefited from federal dollars and should be subject to the same federal transparency rules applicable to other US financial institutions," Palestine Legal's Paul C. Rosen. "In light of the significant dangers that the US
